## Eligible commercial patients may pay as little as



- Eligible patients may pay as little as \$0 copay for IZERVAY, up to \$20,000 per calendar year  
– NDC: 82829-002-01; 82829-0002-01
- Eligible patients may pay as little as \$0 copay for IZERVAY administration, up to \$1,500 per calendar year  
– Please refer to the IZERVAY Billing and Coding Guide or your standard office billing practices for appropriate CPT codes
- Eligible patients must be commercially insured

## How to submit a claim

Submit a detailed Explanation of Benefits from the primary commercial insurance plan, which requires the NDC and CPT codes, through the IZERVAY My Way portal at [IZERVAYMyWayPortal.com](https://IZERVAYMyWayPortal.com), the Commercial Copay Portal at [IZERVAYCommercialCopay.com](https://IZERVAYCommercialCopay.com) (click on Claim Submission in the lower right corner), or via email to [IZERVAYClaims@Paysign.com](mailto:IZERVAYClaims@Paysign.com).

## Ways to receive reimbursement

After you submit claims, choose the way the IZERVAY Commercial Copay Program issues payment to you on behalf of the patient:



Virtual debit card payments are made immediately following claim approval.



EFT payment accounts will be funded within approximately 7 business days following claim approval, and funds will be disbursed to the registered practice banking account.

**You will need to verify your billing and contact information to receive EFT payments. Verification information will be sent to you via email.**

Practices can also receive payment by check. If you would like to change your preferred payment method, call 1-844-303-6567.
